- 1. The contractor will deploy manpower for satisfactory execution of the Jobs under the proposed contract. The manpower engaged by you will work effectively and be responsible for completion of the jobs assigned to them by company's authorized person or contractor.
- 2. The assigned work cannot be outsourced to any other entity.
- 3. GGRC consider at its sole judgment that the drone pilot/ man power / staff deployed by the agency are unsuitable for the scope of work for whatever; the GGRC will request the party for prompt replacement at the party's cost.
- 4. All the agency's employees shall abide by prevailing statutory state and central Govt. laws and GGRC shall not be responsible for any default in this regard by the agency. Agency shall ensure safety/insurance of their staff deployed for the assigned jobs.
- 5. GGRC reserves the right to accept/cancel/reject any/all bids without assigning any reason thereof. The tenders of minimum eligibility criteria qualified Bidder/Bidders shall only be considered for QCBS evaluation.
- 6. Bids shall remain valid and open for acceptance for a period of 60 days from the last date of submission of bids.

## 9. Expression of Interest fees

Rs. 1,000/- plus applicable GST (Total Rs. 1,180/- including 18% GST) EOI Fees shall be payable on the submission of EOI. The fees shall be non refundable. The payment should be made in bank account of GGRC mentioned in point no-9 above.

#### 10. EMD

Agency/Bidder have to upload receipt of direct deposit for EMD of Rs. 10,000/- (Rs. Ten Thousand only). EMD is refundable in case of unsuccessful agency/bidders.

#### **11. Registration Fees**

#### 13. Payment Terms:

Payment shall be released subject to following:

- a. All the payment will be made based on work order based on supporting documents evidence etc., Applicable Income Tax will be deducted from the payment.
- b. Bidder will raise an invoice (hard copy) on completion of work. Payment will be done within 30 days after receiving an invoice.(Weekly/Fortnight or monthly invoice of completed work can be raised)

#### 14. Amendment of Tender

At any time prior to the deadline for submission of Tender, GGRC, Vadodara for any reason, whether at its own initiative or in response to the clarifications requested by prospective interested bidders, may modify the Tender document by amendment.

#### **15. Rejection of Tender:**

The Bidder is expected to examine all instructions, terms, conditions, schedules and other details called for in this specification and keep himself fully informed about all which may, in any way, affect the work, or cost thereof. Failure to furnish the required information or submission of tender not as per the specification will be at the Bidder's risk and may result in rejection.

#### 16. Procedure for submission of Bid:

- I. The Interested bidders shall have to submit required details in Table-1 (Technical bid) along with documentary evidences for pre-qualification
- II. Agencies shall also have to fill up the rate (Financial bid) in Part-E through on line (n-code portal) only.
- III. For financial bid, the bidder shall indicate, in the price schedules, enclosed in the bid proposal sheet, the F.O.R. Destination prices for survey Work as per technical detail it proposes to furnish under the contract, excluding GST and cess along with the total bid price.
- IV. GST shall be applicable at the rate of 9% CGST plus 9% SGST or 18% IGST, or as applicable to composite supplies in the nature of works contract applicable from time to time will be paid within the original contractual delivery period.

## 17. General Instructions

- I. GGRC reserves rights to extend the due date for submission of Tender by issuing an amendment.
- II. EOI, if not supported by required documents as mentioned above will not be considered and the Agency/Bidder would be construed as disqualified.
- III. The agency/bidders submitting EOI without EMD or EMD for lesser amount would be construed as disqualified.
- IV. The Expression of Interest should be prepared in English.

## **18. Intellectual Property**

GGRC retains all rights to its pre-existing intellectual property and any intellectual property it creates in connection with the agreement; and the Bidder assigns to organization all rights in any work product developed.

## 19. Settlement of Disputes And Arbitration

In case any dispute or difference whatsoever arises between the parties hereto in respect of or relating to or touching this tender and Contract from the tender , then the parties shall try to settle every such dispute or differences amicably. Any such dispute or differences, which the parties cannot resolve in an amicable manner, shall be finally settled in accordance with the

Arbitration and Conciliation Act, 1996 and Rules framed there under. The decision of Arbitrator shall be final and binding on the parties. Arbitration proceedings shall be conducted in Vadodara and the language of Arbitration shall be English. Notwithstanding the existence of any such dispute or difference or any reference thereon, the liabilities and obligations under this contract will continue to be fulfilled by the parties hereto during the arbitration proceedings.

#### 20. Jurisdiction of Courts

This shall be construed and governed by the laws of Republic of India and the parties hereby submit to the exclusive jurisdiction of the Vadodara Courts of Law.

#### 21. Comparison and Evaluation of Tenders

The tenders shall be compared on the basis of price quoted by the bidders firm for the entire scope of proposal.

Need basis, GGRC authority will negotiate the price bid offered by successive bidders.

# PART C - SCOPE OF WORK

## Background

The scope of work involves the use of Drone Technology to verify the installation of Micro Irrigation systems in designated fields as per the records provided by GGRC.

## **Primary Objectives:**

- 1. Aerial survey of the Micro Irrigation System using the drone to capture high-resolution imagery.
- 2. Geo Referencing of Micro Irrigation System (MIS) Components and Land Area as a whole.
- 3. Map the location of **Head Unit** (Bye pass valve, filter, ventury/ fertilizer tank/ header assembly/ air release valve etc.) and location of **Field Unit** (Main/ submain pipeline/ emitting pipe/ valve/ sprinkler and other components etc.) all related component of Micro Irrigation Systems
- 4. Assess the condition of the micro irrigation infrastructure (Installed or not).
- 5. Generate accurate and detailed map with GIS attribute information for better management.
- 6. Generate accurate data with the help of kml to generate attribute information.

## Methodology:

- 1. **Primary Data Collection Preparation:** Generating a .kml file based on the provided **manual data.**
- 2. **Drone Setup :** Drone with a high-quality camera (Min. 20 MP preferable) capable of capturing image.
- 3. Flight Planning : Plan the drone flight path according to .kml to cover the farm.
- 4. **GNSS Referencing:** Set GNSS Base and Mark GCP using RTK or PPK. Also provide RTK or PPK correction for drone to get precise GNSS with accuracy of +/-3cms
- 5. **Aerial Data Collection:** Manual data will be provided for water source survey and .kml data generated by agency using manual data must be used for farm aerial survey to get accuracy. Conduct the drone flight to capture imagery with high-resolution videography. From height of 20- 50m (should be adjustable as required)

For each site/ installation/ farmer, the drone should capture the following images:

- Aerial image from a 90° angle to confirm the installation of micro irrigation laying pipes (1 image)
- Aerial image from a 45° angle to confirm the installation of Micro Irrigation (Drip/Mini Sprinkler) system (1 image)
- Aerial image from a 45° or 90° angle, whichever is suitable, to confirm the installation of the Head unit (1 image)

- 6. **Image Processing:** Process the collected imagery using image analysis software Generate and upload analyzed data on Customized online platform designed for micro irrigation system installation survey. Integrate captured image with Google map
- 7. Element Coverage: Cover pipelines, tanks and other elements of the micro irrigation system
- 8. **Data Integration:** Integrate the detected elements with the existing geographical information system (GIS).
- 9. **Data Analysis:** The collected data should be analyzed to prepare comprehensive reports highlighting the status of the Micro Irrigation systems installation and providing detailed information about any issues detected.

## **Deliverables:**

- Raw data of captured High resolution Aerial imagery
- Case to case Raw data, processed data and data access on online platform
- High-resolution image / Orthomosaic maps of the irrigation system that show the location & situation of Head Unit ,Field Unit and or other structures.
- DEM & DTM of irrigation areas./Point cloud information with 3D model and its surroundings.
- Video Clip of farm
- Customized Online cloud-based platform access to view captured data areawise Online cloud based platform features:
  - ✓ Areawise/Farmer wise case to case data sorting and access
  - ✓ Dashboard indicating work progress details
  - ✓ Online report generation with details of Latitude-Longitude confirming system installation or not. The report should be downloadable in Excel format.
  - ✓ Captured data/images can be fetched based on coordinates/farmer details.
  - ✓ Farmer Sub Area integration with Google map with colour code mark. And filter map accordingly
- GIS-integrated data showcasing the location and attributes of the identified features.
- Report of all components of Micro Irrigation system visible from Aerial Photography
- Report describing the results installation of Micro irrigation system
- Documentary Aerial videography clip of farm.

## **Team Capacity**

- Licensed Pilot and Certified drone instructor to conduct safe operation.
- The bidder should have a multiple drone team capacity to be deployed for efficient and timely completion of the project.

Note:

- Approx size of each field is 1-2 Hectare (It may be less than 1.00 Hectare or more than 2 Hectare )
- Sites are not in bunch, they are located at distant area. Hence bidder has to include Transportation expenses in financial bid.
- For operation initialization Manual data will be provided. Then bidder has to prepare required data to conduct Drone survey.
- Coverage: approx. 25 to 30 sites per day
- Empanelled party has to ready to work as per L1 rate received in E-Tender
- District will be allotted for Arial survey of Micro Irrigation System.
