1. Background and Objectives for Implementation of Micro Irrigation Scheme (MIS)

Background

Gujarat Green Revolution Company Limited (GGRC), a Special Purpose Vehicle promoted by Gujarat State Fertilizers & Chemicals Limited, Gujarat Narmada Valley Fertilizers Company Limited, & Gujarat Agro- Industries Corporation Limited is the implementing agencies appointed by Government of Gujarat for implementing Micro Irrigation Scheme (MIS) in entire State vide GR No.PRCH-102005-497-N dt.9.5.2005.

The MI Scheme was launched by Government of Gujarat on 09-05-2005 with total outlay of Rs.1500 Crore with the objective to improve water use efficiency, energy use efficiency and to improve crop productivity, training of farmers for scientific agriculture and to increase farmers' income consequently leading to life standard improvement.

Due to unique way of implementing MI Scheme in corporate manner, under the Scheme, within the period of 16 years, 20.10 lakh hectare area have been covered & benefitted around 12.59 lakh farmers.

Presently 52 Micro Irrigation Companies are registered with GGRC to supply and install Micro Irrigation System in the farmer's field under the MI Scheme. Each installation of Micro Irrigation System is done on farmer's field under the MI Scheme is being inspected by a Third Party Inspection Agency (TPIA) to ensure the quality of supplied Micro Irrigation System components and the Asset transferred to farmer.

Objectives for implementation of MIS in the State

- I. To improve water use efficiency & thereby higher harvest of crop per unit of water.
- II. To improve energy use efficiency in agriculture sector.
- III. To improve crop productivity, increase farmers' income and consequent improvement of their life standard.
- IV. Training of farmers for scientific agriculture through better water management.

Agencies involved in implementing MIS:

- I. Gujarat Green Revolution Company Limited (GGRC) Implementing agency who implements the MI scheme on behalf of Government of Gujarat in the State.

3. Scope of work

Visit & report the status of existence of the Micro irrigation System (MIS) installed on beneficiary farmers field through concurrent monitoring.

This will be verification monitoring of MI System installed in the beneficiary farmer's field and it will be over & above the Third Party inspection & verification of Mi system done for 100% of GGRC cases by Third party inspection agencies.

Agency will have to submit the existing work force deputed in Gujarat, exclusive number of people to be deployed for GGRC work and the preference area/district in **Annexure –IV and V** attached.

Assessment Objectives

- 1. Existence and usage status of the Micro Irrigation System
- 2. Awareness level of the farmer
- 3. Knowledge for Maintenance of the MI System

You shall visit & assess aspects of Micro Irrigation Scheme as per objectives specified above where the questionnaire for field survey is enclosed (Annexure-VI).

Reporting methodology

Concurrent monitoring work is required to be reported online on the software/portal developed by GGRC; special tablets required shall have to be arranged by empanelled agencies.

- I. You shall carryout physical monitoring cum inspection of the MIS beneficiaries farmers field and report to GGRC through online software (field inspection app.) on as & when required bases.
- II. Samples/cases for monitoring will be provided by GGRC as per requirements.
- III. The selected agency's person will visit the actual site of MI System Installation on farmer's field.

- V. You shall submit compiled hard copy report for the inspections carried out cases regularly on monthly basis to GGRC.

Scope & conditions

- 1. Basic Information of sample (farmer beneficiary)
- 2. Assessment objectives as above
- 3. Unit area for the monitoring work & assessment shall be the District/Taluka.
- 4. GGRC will empanel multiple agencies for the subject work.
- 5. Total Samples may be allotted/ distributed amongst empanelled agencies as per their preferred area/district. Final allocation will be at sole discretion of GGRC.
- 6. The minimum sample (MIS beneficiary farmers) size per empanelled agency shall be around 5000 samples for the period of one year.
- 7. The monitoring work will be based on as & when required in particular area/district as per GGRCs directives.
- 8. The work should be done at the site by interacting with MIS beneficiary farmer.

4. Validity of contract:

Total tenure of the empanelment will be 12 months from the date of acceptance of work order.

5. Rates

Interested Agencies are requested to submit the rates as per Table-2 (Commercial bid).

6. Payment Terms

- I. Submission of bill will be on monthly basis.
- II. The payment of the bill will be made by GGRC within 30 days from the date of receipt of final bill every month and verification of the same at GGRC subject to

 - Submission of monthly compiled report

7. Penalty Clause:

Stringent actions including deregistration/blacklisting of the agency would be initiated If agency/any person of the agency is observed/reported to have been involved in irregularities or unethical conduct in connivance/collusion with any of the stake holder.

The Performance Bank Guarantee submitted by agency shall be forfeited under these circumstances.

8. Area of operation:

- I. GGRC will empanel & appoint multiple agencies for the subject work.
- II. The Agency will operate in as per area / districts allotted (max 3-4 districts) by GGRC for activities mentioned as above at the sole discretion of GGRC.
- III. GGRC may change the allotted district/s on quarterly bases.
- IV. GGRC has right to reduce / increase the number of districts allotted to agency which will be binding on agency to render services.

9. General Terms and Conditions

- I. The assigned work cannot be outsourced to any other entity.

- 2. No Individual correspondence will be accepted in this regards.
- 3. Only authorized representatives of Agency/Bidder who can participate and take on the spot decision of the deliberation will be allowed to attend the Pre-bid meeting.

C: Opening Of Expression of Interest

- 1. EOI (complete in all respect) in separate sealed envelope received along with receipt of payment made/ DD towards EMD & EOI/Tender Fee (Physically) on or before closing date and time of tender will be opened. EOI received without EMD & EOI/tender fee will be rejected straightaway.
- 2. EOI of only those Agency/bidders, whose bids are eligible as per criteria will be evaluated.
