PART-: A GENERAL TERMS AND CONDITIONS

(All the bidder are requested to go through general terms and conditions before the filing the any tender documents and to be submitted with technical bid documents)

1.0 In this deed of agreement / Offer, unless the context otherwise requires, GGRC shall mean the Joint Managing Director or his representative of Gujarat Green Revolution Company Limited with Registered & Corporate Office, Fertilizernagar Township,PO Fertilizernagar,Vadodara-391750 and shall include his successors and assignees.

The Bidder shall mean the Bidder / Associate whose offer is received by GGRC as per eligibility criteria and shall include such Bidders / Associate heirs, legal representatives, successors and assignees.

The Bidder shall be deemed to have carefully examined all the papers, drawings, etc. attached in the tender an submit the undertaking as per annexure-I. If bidder has any doubt as to the meaning of any portion of any condition / specification, etc. he shall before submitting the bid seek clarification from GGRC so that such doubts are removed.

The GGRC shall evaluate the techno-commercial view of the tender. GGRC reserves the right to open or not to open the Preliminary/Technical/ Price bid of the bidders on the basis of their past performance in implementation of Micro Irrigation Scheme in GGRC as well any other State Implementing Agencies.

- 1.1 Tender should be submitted in three bids system.
 - I. Preliminary Bid documents of tender are to be submitted in physical form as well as Online mode.
 - i. The bidder who want to register as new MIS supplier has to submit the Non Refundable Rs 10,000 as Tender fees in "Tender Fees Cover" and Rs 3,00,000/- as EMD (Earnest Money Deposit) in "EMD Cover" separately in online as well as physical mode of submission within the due date of tender at GGRC. The Tender Fee Cover and EMD cover should be kept in an envelope superscripting as follows

- ii. The Tender Fees and EMD should be submitted in the forms of DD in favour of Gujarat Green Revolution Company Limited, payable at Vadodara.
- iii. The bidder who is registered as Micro Irrigation System (MIS) Supplier of GGRC as on date of advertisement of this tender is exempted from payment of any Tender Fees and EMD amount. However, the bidder who is interested to register in GGRC as New MIS Suppliers should submit the Tender Fees and EMD in GGRC as specified above
- II. Technical Bid documents of tender are to be submitted in physical form as well as Online mode as mentioned in part-B of this tender as follows.

A. FOR BIDDERS WHO ARE REGISTERED MIS SUPPLIER UNDER THE MIS SCHEME IMPLEMENTED BY GGRC IN THE STATE AS ON DATE OF ADVERTISEMENT OF THIS TENDER.

Those MIS Supplier who are Registered under the MIS scheme implemented by GGRC during the year 2017-18 need not to submit the technical bid online/physical mode.

These MIS Supplier have to submit a declaration form (Annexure-I) and submit it in online as "Technical Bid" as well as in Technical Bid documents cover in physical form super scribed as mentioned in 1.1(I)(i).

B. FOR BIDDERS WHO ARE INTERESTED TO REGISTER AS NEW MIS SUPPLIER UNDER THE MIS SCHEME IMPLEMENTED BY GGRC IN THE STATE AS ON DATE OF THIS TENDER

Those MIS Supplier who is interested to register as new MIS supplier under the MIS scheme implemented by GGRC has to submit a declaration form (Annexure-I) along with the physical documents as specified under Part B (Technical Bid) *in "Technical Bid documents cover"* super scribed as mentioned in 1.1(I)(i) as well as upload the scan copy of documents in online bid as mentioned in Part-B (Technical Bid) of this tender document. However, the bidder may upload additional documents, brochures, technical / other information etc, if desires to give with the bid.

III.PRICE BID (ONLINE MODE ONLY)

- i. The Registered MIS Supplier as well interested MIS Supplier for new registration has to submit the price bid in online mode only. This is mandatory which may please be noted
- ii. If price bid is submitted in physical form, same will not be accepted and only on-line submitted price bid will be considered for evaluation. The MIS component along with its technical specification is mentioned in Part C-Price Bid document of this tender.

- iii. Those bidders who does not submit the price bids in online mode will be out rightly rejected by GGRC and does not eligible for registration/renewal as MIS supplier in GGRC.
- iv. Once price is quoted by bidders in Price Bid will not be changed under any circumstances.
- v. The price bid of those bidders who are technically qualified shall only be opened.

Please note that the required documents should be invariably uploaded in online / submitted in physically as mentioned in tender. Any tender without required documents is liable to be ignored and the tender may be rejected without entering in to any further correspondence in this regard and no further reference will be made.

2.0 TENDER EVALUATION CRITERIA:

The Tender Bid will be evaluated as follows

2.1 PRELIMINARY BID:

The Bidder will have to submit the Tender Fees of Rs 10,000/- as well as EMD amount of Rs 3,00,000/- by DD in favor of Gujarat Green Revolution Company Limited payable at Vadodara. The bidder have to submit his Physical and Online bid by due date of tender submission in GGRC. The Bids found without Tender fees and EMD amount and submission of physical document after due date will be out rightly rejected by GGRC.

The Registred MIS Suppliers of GGRC as on date of advertisement of this tender is exempted from submission of Tender Fees as well as EMD amount.

2.2 TECHNICAL BID:

I. FOR BIDDERS WHO ARE REGISTERED MIS SUPPLIER UNDER THE MIS SCHEME IMPLEMENTED BY GGRC IN THE STATE AS ON DATE OF ADVERTISEMENT OF THIS TENDER.

Those MIS Supplier who are Registered under the MIS scheme implemented by GGRC as on date of advertisement of this tender need not to submit the Technical bid-Part B of this tender in online as well as physical mode.

However, these MIS Supplier need to submit a declaration form (Annexure-I) and submit it in online as "Technical Bid" as well as in Technical Bid documents cover in physical mode.

II. FOR BIDDERS WHO ARE INTERESTED TO REGISTER AS NEW MIS SUPPLIER UNDER THE MIS SCHEME IMPLEMENTED BY GGRC IN THE STATE AS ON DATE OF THIS TENDER

Those bidders who is interested to register as new MIS Supplier under the MIS scheme implemented by GGRC has to submit the physical documents *in* "Technical Bid documents cover" as well as upload the scan copy of documents in online bid as mentioned in Technical bid-Part B of tender document. However, the bidder may upload additional documents, broachers, technical and other information etc, if desires to give with the bid.

Please note that the required documents should be invariably uploaded in online and submitted in physical mode as mentioned in tender. Any tender without required documents is liable to be ignored and the tender may be rejected without entering in to any further correspondence in this regard and no further reference will be made.

The bids of only those bidders who have submitted the required documents in physical form under sealed cover of "Technical Bid cover" and submitted required details and documents in on-line in respective Annexure will be considered for technical evaluation.

GGRC reserves the right to accept or reject any or all the tenders. Decision taken by GGRC shall be final and binding on all.

2.3 PRICE BID:

All Bidders i.e. Registered OR Interested to Register as new MIS Supplier in GGRC shall mandatory quote rates for the MIS Components of Micro Irrigation System i.e. Drip Irrigation, Mini Sprinkler, Drip Tape, Porous Pipe, Conventional Sprinklers System, Rain Gun and Ancillary Components (Outsourced/Self Manufactured). The Bidders shall quote rates only for that type of MIS system for which they are registered in GGRC or interested to register in GGRC.

All bidders (whether registered or interested to register as new MIS supplier) have to quote rates for all ancillary components required for the Micro Irrigation System. The responsibility to ensure the quality and quantity of OEM outsourced components is lies on the bidders.

The list of MIS components, technical specification and GGRC base price is attached in Price Bid-Part C of this Tender. It is to be noted that MIS component quoted rate by bidders should not be higher than prevailing GGRC price.

For Re-Discovery of MI Component prices, the evaluation of quoted rates will be carried out irrespective of the registration status of bidders in GGRC i.e. **Registered or Interested for registration as new MIS Supplier**. The MIS Component quoted rates should be exclusive of GST or any Levies. Bidder shall indicate bid prices in Indian Rupees only.

3.0 PRICE EVALUATION:

No price preference shall be given on any account. After the evaluation of bids received in the tender, GGRC will declare the Lowest1 (L-1) end cost which shall be applicable to all registered as well as interested for registration as new MIS supplier of GGRC. It is to

be noted that those MIS supplier who accept and match the Lowest1 (L-1) end cost for all components ONLY will be given registration or will be renewed as Registered MIS Supplier under the MIS scheme implemented by GGRC in the State. GGRC'S decision of price evaluation shall be final and binding on all the parties.

GGRC reserves the right to accept or reject the MIS Components rates offered in price bid. However if L-1 rates are not as per prevailing market rate, the GGRC reserves its right to re-discovery of MIS Component wise price through online reverse auction system.

4.0 ALLOCATION OF MIS AREA COVERAGE TARGET:

The bidders who have quoted L-1 price for the maximum numbers of MI components and overall Lowest-1 (L-1) may be considered for higher tentative allocation of MIS area coverage Target (In Hectare). However, the tentative allocation of MIS area coverage Target will depend upon their production capacity, financial capacity, quality performance, and marketing/administrative network in the State, Supply and Past performance with GGRC.

5.0 EFFECT AND VALIDITY OF TENDER OFFER:

The offers received under this tender will be valid for 120 days and its validity may be extended at the discretion of GGRC. In case of finalization of the tender is likely to be delayed, the bidders will be asked to extend the same without change in the prices or any terms and conditions of the offer. If any change is made, original or during the extended validity period, the offers will be liable for outright rejection without entering into further correspondence in this regard and no reference will also be made.

The submission of any bid connected with this tender shall constitute an agreement that the bidder shall have no cause of action or claim, against GGRC for rejection of their bid. GGRC shall always be at liberty to reject or accept any bid or bids at its sole discretion and any such action will not be called into question and the bidder shall have no claim in that regard against the GGRC.

6.0 LANGUAGE OF THE TENDER

All information in the bid shall be in English. Information in any other language shall be accompanied by its translation in English. Failure to comply with this may disqualify a bid. In the event of any discrepancy in meaning, the English language copy of all documents shall govern. Notarized copy of certificate / documents provided in Hindi / Gujarati will be accepted.

7.0 AMENDMENT OF TENDER

At any time prior to the deadline for submission of Tender, GGRC, Vadodara for any reason, whether at its own initiative or in response to the clarifications requested by

prospective interested bidders, may modify the Tender document as per the amendment.

The same amendment will be notified on GGRC website (www.ggrc.co.in) as well as in leading local news paper and changed modification will be binding on them. The bidders are expected to visit the GGRC website as well as news papers regularly for any updation regarding the tender. In order to allow prospective bidders a reasonable time to take the amendment into account in preparing their Tender document, GGRC, Vadodara, at its discretion, may extend the deadline for the submission of Tender.

8.0 REJECTION OF TENDER

The Bidder is expected to examine all instructions, terms, conditions, schedules and other details called for in this specification and keep himself fully informed about all which may, in any way, affect the work, or cost thereof. Failure to furnish the required information or submission of tender not as per the specification will be at the Bidder's risk and may result in rejection.

The offer may be rejected in case the bidding schedules / annexure are not filled/partially filled and if particulars are not given in format prescribed in the tender documents.

Further, the offer may summarily be rejected if it contains conditions with regard to:

- a) Different rates for the same items i.e. Rates should be quoted in the single slab only.
- b) Deviation / Addition / Alternations / Omissions in bidding documents.
- c) Deviation and contradictions to the terms and conditions specified in this tender.
- d) Revision of prices or any commercial terms affecting the price after opening of technical bids shall not be considered and will be ignored.

9.0 GGRC's RIGHTS

The GGRC reserves the right to cancel the tender at any time without any notice or the reasons thereof. Bidders will have no right to claim for any compensation / damages / losses, whatsoever, on account of such cancellation of tender.

The Bidders shall specifically note that any overwriting or corrections or manuscript in the bid shall be ignored and will not be considered authentic unless same are signed and Bidder's Stamp / Seal is affixed.

In case of any doubt or interpretation of the terms and condition, the decision of the GGRC will be final and binding upon the Bidders and no dispute in this regard will be entertained.

GGRC reserves the right to accept any bid or reject any or all Tenders or cancel / withdraw or re invitation to bid without assigning any reason. Such decision of the GGRC shall not be subject to question by any Bidders and the GGRC shall bear no liability whatsoever for such decision.

10.0 JURISDICTION OF COURTS

The laws applicable to the Tender shall be the laws in force in India. The courts of Vadodara City limits shall have exclusive jurisdiction in all matters arising under this contract.

11.0 INDEMNITY

The bidders agrees to defend, indemnify and hold harmless GGRC, its officers, directors, agents, employees and affiliates (and their respective officers, directors, agents and employees) from and against any and all claims, liabilities, actions, demands, judgments, losses, costs, expenses, suits, actions and damages arising by reason of bodily injury, death or damage to property sustained by third parties that are caused by an act of negligence or the willful misconduct of the bidder, or by an officer, director, sub-contractor, agent or employee of the bidder.

12.0 FORCE MAJOURE

If, at any time during the continuance of this contract, the performance in whole or any part by either party of any obligation under this contract shall be prevented or delayed by reason of any war, hostility, act of the public enemy, civil commotion, sabotage, fires, floods, explosion, epidemics. Quarantine restrictions, strikes, lock-outs or acts of god (hereunder referred to as event)" then provided notice of the happening of any such event is given by either party to the other within seven days from the date of occurrence thereof neither party shall be reason of such event be entitled to terminate this contract nor shall either party shall have any claim for damages against the other in respect of such non-performance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such event has come to end or ceased of exist, and the decision of the Joint Managing Director, GGRC as to whether the deliveries have been so resumed or not shall be final and conclusive.
